## CLASSES

### Conflict/Anger Management:

#### **Zoom with instructor – 2 hours**

Our instructor led Anger Management class helps participants identify anger triggers and gives them clear direction on how to mitigate the effect those triggers have in life. Participants are encouraged to be open and forthright about the origin sources of anger and conflict-based behaviors. Diversion Solutions provides participants clear direction on ways to manage anger triggers long-term.

### Drug/Alcohol:

#### **Zoom with instructor – 2 hours**

This class is centered on utilizing interactive restorative justice-based techniques to determine origin sources for drug/alcohol use. Interactive conversation led by the class instructor will focus on accountability, acceptance of action, and forward movement. Diversion Solutions believes that a focus on the “why” of a person’s actions is just as important as focusing on the “what”.

### DWI/DUI 8 Hour Class:

#### **Zoom with instructor**

This class involves looking at the issues of DWI/DUI situations and how they impact society, the victim and the person charged. It also explores the physical and emotional impact of drug and alcohol use, what issues trigger drug and alcohol use and what alternatives are to that use.

### MADD VIP

#### **Payment made directly to MADD**

Class conducted by MADD. DS monitors attendance on DWI monitoring requests. Individual would also attend DS Drug Alcohol Class.

## CLASSES

### Parenting:

#### **Zoom with instructor – 2 hours**

Discussion on the role of being the parent. Learn skills to teach self-discipline, cooperation, responsibility, and problem solving by utilizing mutual respect and communication. Class included short activities, group sharing and voluntary role-play.

### Personal Leadership:

#### **Zoom with instructor – 2 hours**

Teaches individuals how they are responsible for themselves, to achieve their full potential, discover steps to developing strong character, apply principles that can make life better and begin changes in thought and actions.

### Power of Attorney Responsibility & Elder Abuse:

#### **Zoom with instructor – 2 hours**

This class covers how elder abuse was determined, how to not get into this situation, covers the rights and how to be responsible with Power of Attorney and money.

### Theft/Shoplifting/Fraud/Property Damage:

#### **Zoom with instructor – 2 hours**

This class focuses on educating the participant on the overall effects caused by theft/fraud/property damage actions. Diversion Solutions utilizes intentional questioning to help a participant understand the reasons why they engage in destructive, theft-based behaviors. Class directives are completed by the participant writing a Victim’s Impact letter intended to give the participant the opportunity to take responsibility for actions made against a victim.

## CLASSES

### Traffic Education Program (TEP):

#### **Online – no instructor – 40 minutes**

This class acts as a refresher course focusing on the 36 most common traffic citations. Participants are required to watch an online instructional video that details common driving errors and informs on proper driving technique. Participants are also required to take a mandatory knowledge based exam before successfully completing the TEP class.
